#### Conformance status

The Web Content Accessibility Guidelines (WCAG) defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA. ICLR.4 is partially conformant with WCAG 2.1 level AA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard.

### Limitations and alternatives

Despite our best efforts to ensure accessibility of ICLR.4, there may be some limitations. Below is a description of known limitations, and potential solutions. Please contact us if you observe an issue not listed below.

Known limitations for ICLR.4 and/or the ICLR website:

- 1 ICLR case report PDFs: Some older case report PDFs are not text searchable or screen-readable because The PDFs are images of print book pages. We are reprocessing the older PDF content to create a readable text version. There is an equivalent HTML version of all same case reports from ICLR.
- Site navigation: Navigational elements including headers, buttons, and links are not consistently placed or labelled. The number of different types of content displayed on the site on different pages make it difficult to maintain a consistent arrangement of navigational elements. However, most navigational elements can be operated by keyboard.
- 3 **Site navigation**: Some functions and selections are not fully keyboard operable because Accessibility improvements have yet to be implemented in these areas. We are continuing to improve accessibility on the site. Contact us for assistance with specific research tasks requiring a mouse.
- 4 **Alt text for images**: some images may be missing alt text. We are working towards ensuring all images are properly tagged.
- 5 **Optimisation** Some pages may not display well on smaller screens. A responsive design upgrade is in progress.
